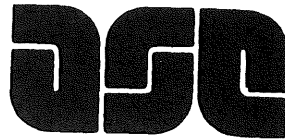
**MICHAEL J. HINDELANG AWARD**

**For the Most Outstanding Contribution to Criminology**

The American Society of Criminology has established the Michael J. Hindelang Award, to be given annually for a book published during the previous two to three years that makes the most outstanding contribution to research in criminology. The Award will be presented during the annual meeting of the Society. The Executive Board may decide not to give the Award in a given year.

The Award Committee is soliciting nominations for the Michael J. Hindelang Award. To nominate a book, please send the title of the book, its authors, the publisher, the year of the publication, and a brief discussion of your reasons for the recommendation to the Award Committee. ## NOMINATIONS FOR 1995 ASC AWARDS

The ASC Awards Committee invites nominations for four major awards, to be presented at the 1995 annual meetings. The awards:

**EDWIN H. SUTHERLAND AWARD**, which recognizes outstanding scholarly contributions to the discipline of criminology by a North American criminologist. Outstanding scholarly contributions may consist of a single outstanding book or work, a series of theoretical or research contributions, or the accumulated contributions of a senior scholar.

**THORSTEN SELLIN & SHELDON AND ELEANOR GLUECK AWARD**, which recognizes outstanding scholarly contributions to the discipline of criminology by a non-North American criminologist (i.e., not U.S. or Canadian). The recipient need not speak English; however, his/her work must be available, in part at least, in the English language (either by original publication or through translation).

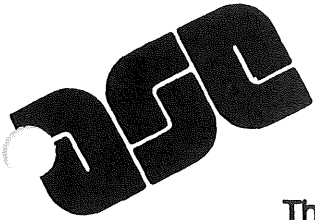
**AUGUST VOLLMER AWARD**, which recognizes outstanding contributions to applied criminology (criminological practice or policy). The award may be given for a single major effort or work, a series of contributions, or accumulated contributions to practice of policy.

**HERBERT BLOCH AWARD**, which recognizes outstanding service contributions to the American Society of Criminology and to the professional interests of criminology.

In submitting your nomination, provide the following supporting materials: a letter evaluating a nominee's contribution and its relevance to an award, and the nominee's c.v. (short version preferred). No nominee will be considered unless materials (c.v., etc.) are available and arrive by deadline.

I'm writing to ask for your assistance. As you know, Marjorie Zatz has been a dedicated and committed member of ASC for many years. Her work on behalf of the organization has not just been continuous and tireless, it has also really mattered. She has served as chair of the Fellows Awards Committee and the Division on Women and Crime's Nominations Committee; she has also served as a member of the Strategic Planning Committee, the Local Arrangements Committee, the Fellows Award Committee, the ASC Nominations Committee (for 4 years!), the Program Committee, and the Constitution and By-Laws Committee; she has also served as an elected member of the International Division's Executive Council, and she currently serves as an elected member of ASC's Executive Council.

I am helping to organize a letter writing campaign to nominate Marjorie for the Herbert Bloch Award for ASC. The Bloch award "recognizes outstanding service contributions to the American Society of Criminology and to the professional interests of criminology." Many of us believe that Marjorie's service to ASC has been exemplary and qualifies her for this prestigious award. But what is even more striking is that Marjorie has contributed to the profession by serving on key committees in several other organizations as well, including the Society for the Study of Social Problems, (she is finishing her term as Division Chair for the Crime and Delinquency Division), the American Sociological Association (she has served on several committees within the Crime, Law and Deviance Section, including the Executive Council), and the Law and Society Association (again, she has served on the Executive Council and on several committees). In addition she has served the profession in numerous other ways - too many indeed to list in an e-mail message!

I am sending this message to just a handful of people that have been identified as especially informed about Marjorie's contributions to the profession. I am asking for your help in placing Marjorie's name in nomination for this award. Because the strength of the nomination

depends in part on the number of people writing letters of support, it is my hope to obtain a minimum of five letters of support on behalf of Marjorie. I would like to ask if you would be willing to be among those writing a letter of support. I know that it is difficult to find the time to perform tasks like this, but in the end it is a small thing that we can do to let dedicated colleagues know how much we have appreciated their efforts.

If you would be able to write a letter on Marjorie's behalf, please let me know immediately and I will FAX you a copy of her vita. Letters of support must be received at the ASC office BY MARCH 1, 1997 - so it is critical that we act swiftly! If you are not able to write a letter, please let me know so that I can ensure that enough nominations go forward to make Marjorie a viable candidate.

**Division on Women and Crime  
Award for Outstanding Contributions**

(Approved October 29, 1993)

The Division on Women and Crime (DWC) will present an award(s) annually to a member(s) of its division who has made outstanding contributions to either:

- (1) the development of knowledge about feminist scholarship, gender issues, or women as offenders, victims or professionals in the criminal justice system, or
- (2) the enhancement of women's status within criminology and criminal justice through contributions to professional organizations, academic institutions, and/or the criminal justice system.

The process of nominating and selecting candidates for the Division on Women and Crime Award for Outstanding Contributions involves the following:

- (1) A DWC Selection Committee of three members will be appointed by the current Chair of the DWC based upon nominations and volunteers who have expressed interest in serving on the committee. The Chair will attempt to appoint people who represent a cross-section of the DWC membership, including age, experience, type of fields or expertise, academic/practitioner, race, ethnicity, and geography.

Nominations for the Award will be called for at the DWC annual meeting. Nominations will further be solicited in the following DWC newsletter, which should be mailed no later than the following mid-January. A deadline for nominations should be set for the end of February each year. All nominations should either be accompanied by vitae of the nominees, or the nominees contacted and asked to send them to the Chair of the Awards Committee by late March.

Selections will be made and forwarded to the Chair of the DWC by June of each year.

The Chair and the Executive Committee of the DWC will decide in what form the DWC Award for Outstanding Contributions will be made (i.e. plaque, certificate, financial award). The person who receives the award should be written up in the following DWC Newsletter with an explanation of why she/he was selected to receive the Award.
