The expansion of educational opportunity has been a continuing theme in the planning of the University of North Florida from its inception. Many men and women in this area clearly possessed the ability and motivation to further their education, but their aspirations were thwarted because they lacked the financial resources to continue. Therefore, a program of student financial aid was developed to assist able and motivated students who, only with financial aid, could achieve their goals. It was apparent that the needs of University of North Florida students would require support from voluntary gifts (both to match government awards and to supplement them). Trustees of the newly formed University of North Florida Foundation took as their first task the development of a program to enlist the necessary gift support. More than 250 private individuals, business enterprises, and civic organizations responded, earning the designation "Volunteer Alumni." Their combined gifts, totaling \$38,000, assisted 211 students in the Charter Class of the University.

Forty-nine of these donors contributed \$500 or more and were designated "Honorary Founders." The permanent plaque being unveiled today is in recognition of those who laid a foundation for opportunity from which generations will benefit.
