1. Whereas, We, as students, are working towards the achievement of a better  
2. society through our educational endeavors, and  
3. Whereas, achievement of this goal can only be met within an egalitarian  
4. environment, and  
5. Whereas, the Equal Rights Amendment would ensure the chance that all persons  
6. can live and work in an equal society, and  
7. Whereas, the Equal Rights Amendment would provide this chance by adding to  
8. the United States Constitution, the following:

9. Section 1:

10. Equality of Rights under the law shall not be denied or abridged by  
11. the United States or by any State on account of sex.

12. Section 2:

13. The Congress shall have the power to enforce, by appropriate legislation,  
14. the provisions of this Article.

15. Section 3:

16. This amendment shall take effect two years after the date of ratification.

17. Therefore, Let It Be Resolved: that the Student Government Association of the  
18. University of North Florida, Jacksonville, representing five thousand (5,000)  
19. students, strongly endorse and support the passage of the Equal Rights  
20. Amendment; and,
