Please describe PP involvement/background

I have served both currently and formerly on Planned Parenthood of Northeast Florida Board of Directors, first from 1992 to 1997 and currently from 2007 to the present. I have also served on both the Legislative Committee and Fundraising Committee. I have lobbied the State of Florida Legislature innumerable times in previous years, and currently I continue to lobby individual elected officials and candidates on pro-choice issues.

Present Community...

I am appointed by both Mayor John Delaney and Mayor John Peyton to the Jacksonville Commission on Human Rights and am currently serving. I serve on two FBI groups: Stop Hate Crime Committee and the FBI's Cultural Committee. I am currently a member of and former Board of Director of Uptown Civitan Association. I am the Founder of the Jacksonville Women's Network. I am a member (and was convener in 1969) of the National Organization for Women. I am currently a judge for a city-wide EVE (Employment/Volunteer/Education) award. I belong to Leadership Jacksonville, the Jacksonville Community Council (JCCI), St Johns Riverkeeper, etc.

Previous Community Affiliations

I was convener of the University of Florida National Organization for Women. I was State of Florida President of the Florida Women's Political Caucus. I was appointed by Jacksonville Mayors to the Ritz and LaVilla Cultural District Commission, the Duval County Hospital Authority, and the Jacksonville Planning Board. I served on the Karpeles Manuscript Museum Board. I was a member of Wage Peace, Florida Women's Alliance, ERA America, etc.

Fund Development

I served on Planned Parenthood Fundraising Committee from 1998 to 2008. I was a patron for Hubbard House Shelter for Abused Women (1992-1994).

## Fund Development (continued)

I was Director and major fundraiser for ERA (Equal Rights Amendment) Jacksonville in 1996. I am also a fundraiser (and contributor) for various political candidates—especially Hillary and Bill Clinton. Also I was involved in fundraising for the John F. Kennedy Center for Performing Arts. I am both a volunteer and a contributor to various political campaigns.

## Political Affiliations

I was appointed by President Clinton to the President' Advisory Committee on the Arts of the John F. Kennedy Center for the Performing Arts. I was appointed by Florida's Governor Lawton Chiles to "Florida's Finest", an honor that recognized Florida residents who improve their community through good deeds and hard work. I am recipient of Mayor John Delaney's award as "A Woman of Courage and Vision" (2001). I am elected to the Duval County Democratic Executive Committee.

## Experience

I am involved in my community in both a humanitarian and political sense. My field of study as a professor is in communication, a word that means "a coming together", as in "a sense of community."

## Diversity

I represent the knowledge of experience ( I am 73). I am a WOMAN. I am a feminist. I am slightly handicapped: I use a cane. I am experienced in social struggles and issues. I know how to effect change.
