Re: IWY Conference

Dear ACLU Member:

Nearly 2,000 delegates from the 50 states and the territories will represent the nation's women at the upcoming National Women's Conference in Houston. While only elected delegates may vote, supporters throughout the country are coming to Houston to attend workshops and special events and to lend support to their delegates. The importance of the IWY Conference must be underscored for the public visibility it will give to the credence and solidarity of the women's movement.

Many groups and several state delegations - both from the right and from the women's movement - are contemplating further refinement of the National Plan of Action, the resolutions adopted by the state conference and by the IWY Commission. Because there are 38 resolutions on the floor at present and because of the wide political spectrum of debate on these issues, we would urge you individually and through your state delegation to weigh carefully the advisability of further amendments. In fact, it is our current thinking - supported by the Pro-Plan Caucus - that the most effective way of dealing with anticipated political diversity is to have a united position to endorse the National Plan of action in its entirety.

We have evaluated each resolution and find each to be consistent with the mutual goals of equal rights for women and of civil liberties concerns. Clearly, we may have wished further refinement on some of the issues, but feel that attempts in this regard will simply entangle the process and jeopardize the passage of the National Plan.
