## STUDENT GOVERNMENT ASSOCIATION SENATE LEGISLATION

Number SGA Bylaw Amendment 925-719

Whereas

The University of North Florida Student Government Association has operated under Standing Rule 91S-653, which reads as follows:

1. A Senator MUST abstain from voting on Senate legislation if the legislation names a club and/or organization, other than Student Government Association, of which the Senator is a member and/or officer, and

2. A Senator SHALL NOT draft Senate legislation which names a club and/or organization, other than Student Government Association, in which that Senator is a member and/or officer, and

3. A Senator MUST abstain from voting on any legislation if he/she will directly benefit from the passage of that legislation excluding ONLY legislation which is intended for the functioning of the Student Government Association itself, and

4. Prior to the participation in the question and answer and debate periods, any Senator who will, by adoption of this legislation, be required to abstain on said pieces of legislation, shall announce the fact that an abstention is pending.
