Therefor: Let it be resolved that the University of North Florida Student Government Association does not condone the distribution or dissemenation of racist material at the University of North Florida.

Motion was made to suspend the bylaws to consider SR 93F-786. Passed by

unanimous consent. Motion to amend the words, "does not condone" to "condemns." Passed 25-0-2

Motion to amend the word "racism" to "prejudice". Fails 2-23-2 Motion to amend the third "Whereas" statement to read, "Racism is the explicit or implied degredation of any race, which stems from ignorance. Passed 17-3-3

Motion to amend the fourth stanza, to add, "any act of the distribution or dissemination of racist material at the University of North Florida. SGA also denounces the advocation of faculty and/or staff on participating in the circulation of such material. Passed 22-0-2
