

# THE 1992 DEMOCRATIC NATIONAL CONVENTION

The 1992 Democratic National Convention will be held July 13-16 in New York City. 4,922 delegates are scheduled to attend the convention for the purpose of electing the Party's candidates.

## FLORIDA'S DELEGATION

One hundred sixty (160) delegates and twenty five (25) alternates will be chosen to represent Florida at the convention making Florida's delegation the seventh largest.

Florida voters will determine the number of Florida's delegates awarded to each presidential candidate by their vote on SUPER TUESDAY - the Presidential Preference Primary to be held on March 10, 1992. Votes will be cast at regular polling locations throughout the state.

Florida's delegate positions will be divided proportionately among the candidates that receive at least 15% of the popular vote in the primary.

## HOW FLORIDA'S DELEGATES WILL BE CHOSEN

Three categories of delegates and alternates will be chosen in Florida:

- *District Level* - Elected in congressional district caucuses on March 28, 1992.
- *Pledged Party Leader and Elected Official* - Chosen by the Democratic Party State Executive Committee on May 9, 1992.
- *At-Large* - Chosen by the Democratic Party State Executive Committee on May 9, 1992.
