SENATE LEGISLATION

NUMBER SB-96S-928B

Whereas: The O.B.C. Is responsible for the internal procedures of the Student Government Association, as those procedures pertain to the Student Constitution and Constitutional Statutes.

- Whereas: The documents to be acted upon by the Organization and Bylaws Committee will be the Constitution and Constitutional Statutes.
- Whereas: The duties of the O.B.C. Will be:
 - a. To interpret the Student Government Association Constitution and Statutes and resolve conflicts concerning said documents.
 - b. To review the Student Government Association Constitution and Statutes and recommend any changes to the Student Government Association Senate when necessary.
 - c. To review all appeals for Senator absences. The committee's recommendations will be forwarded to the Senate.
 - d. To validate all petitions to recall a Student Government Association Officer or Senator in accordance with the Constitution and Statutes.
 - e. Responsible for maintaining and following a current S.G.A. Policies and Procedures manual. Any revisions to this document must be approved by a two-thirds (2/3) vote of the committee and the Senate.
- Therefore: Let it be resolved that the Organization and Bylaws Committee be renamed the Constitution and Statutes Committee (C.S.C.) and perform only the aforementioned duties. Also let it be resolved that SB-96S-928B replace Art. IV, Sec. 5, Subsect. 5b. Respectfully submitted, <u>Rich Chang</u>, <u>Senate President</u>
