SENATE LEGISLATION

NUMBER Senate Resolution 96F-951

- WHEREAS:** The University of North Florida is made up of 11, 200 students, and
- WHEREAS:** The Student Fee Assessment Committee was convened to review and set student fees, and
- WHEREAS:** The Student Fee Assessment Committee recently voted to increase the student Athletic Fee by \$.75 to \$ 7.00, and
- WHEREAS:** The student members of the committee were aware of the Athletic Department's needs and were in favor of an Athletic Fee increase, and
- WHEREAS:** The Athletic Department requested a \$.60 increase in the Athletic fee, and
- WHEREAS:** The student members of the committee voted against a \$.75 increase in the Athletic Fee, but voted for a \$.60 increase, and
- WHEREAS:** The faculty, staff, and administration members of the committee voted for a \$.75 increase in the athletic fee, but voted against a \$.60 increase, and
- WHEREAS:** The vote of the Student Fee Assessment Committee serves as a recommendation the University President, and
- WHEREAS:** The recommendation of the committee shall take effect only after approval by the University President, after consultation with the Student Body President, with final approval by the Board of Regents, therefore

BE IT RESOLVED BY THE STUDENT GOVERNMENT SENATE THAT:

The University President, Dr. Adam Herbert, should override the committee's recommendation for a \$.75 increase in the Athletic Fee, and support a \$.68 increase, given \$.68 is the middle ground.

BE IT FURTHER RESOLVED THAT:

A copy of this resolution, including the official seal of the University be sent to the members of the Student Fee Assessment Committee, the Vice President of Student Affairs, the University President, and the Board of Regents.
