SENATE LEGISLATION

NUMBER SB-97S-967

WHEREAS: The Student Conferences / Travel Account (#907027000) was established to enable students to represent the University and gain valuable personal experience through various activities at a lower cost, and:

WHEREAS: Funding of this account depends upon the Unallocated Reserves Account (#907098000), and:

WHEREAS: The available balance of the Student / Conferences Travel Account (#907027000) before any legislation is submitted is \$5,253.27, and:

WHEREAS: We currently have \$ 7768.23 pending in legislation, and if enacted upon, will overdraw the existing account by \$2,514.96, and:

WHEREAS: There is presently \$ 39,718.00 in the Unallocated Reserves account (#907098000) for just such a contingency, and:

WHEREAS: I propose to the Distinguished Members of the Senate to transfer \$10,000.00 to the Student Conferences / Travel Account (#907027000) from the Unallocated Reserves Account (#907098000), which would leave a ~~\$2,231.77~~ available for future requests, and:
\$7485.04

THEREFORE: Let it be enacted upon to transfer \$10,000.00 from the Unallocated Reserves Account (#907098000) to the Student Conferences / Travel Account (#907027000) in order to remain in accordance with procedure regarding the handling of SGA accounts as dictated in the Student Government Statutes (Article VIII. Ch.801.3, CH.801.9).
