SENATE RESOLUTION

NUMBER SR - 98S - 1065

WHEREAS: The Student Government Association at the University of North Florida are duly elected representatives of the Student Body, and;

WHEREAS: The Student Government Association's purpose is to represent student interests in all University-wide matters while developing and promoting a cohesive and equitable relationship with the administration, staff, and faculty, and;

WHEREAS: The UNF Faculty Association has drafted a Resolution suggesting there be segregated parking on campus for instructors, and;

WHEREAS: On behalf of the Student Body, the UNF Student Government Association is opposed to such a motion for designated or preferential parking, and;

WHEREAS: The OVERWHELMING consensus of the Student Body deems such an action as unacceptable and infringes upon the specific *Mission Statement* pertaining to "...providing a campus environment focused on the needs of the University's clients", and;

THEREFORE: LET IT BE RESOLVED THAT THE UNIVERSITY ADMINISTRATION TAKE THIS RESOLUTION INTO CONSIDERATION AND REJECT SUCH A PROPOSAL FROM ANY ENTITY AT THE UNIVERSITY OF NORTH FLORIDA; SUCH A PROPOSITION WOULD BE DEEMED AN AFFRONT TO MAINTAINING AN EQUITABLE RELATIONSHIP BETWEEN ALL CONSTITUENTS AT THE UNIVERSITY OF NORTH FLORIDA.

LET IT BE FURTHER RESOLVED THAT: A COPY OF THIS RESOLUTION BE SENT TO THE MEMBERS OF THE UNF FACULTY ASSOCIATION, THE VICE PRESIDENT OF STUDENT AFFAIRS, THE UNIVERSITY PRESIDENT, THE CHANCELLOR OF THE STATE UNIVERSITY SYSTEM, AND THE BOARD OF REGENTS.
