SENATE LEGISLATION

NUMBER SB-99S-1111

SB-99S-1111 addresses Executive Cabinet reports at Senate meetings.

WHEREAS:

The UNF Student Government Associations Constitution, Statutes and Procedures states in Title IX: <u>The Enforcement Statutes</u>, Subsection 901.1.C.1.a "The Constitution and Statutes Committee shall have the jurisdiction over all Student Government Association Statutes, except for Title VI and Title VIII, legislative actions and rules and procedures." Correspondingly, It is the duty of the Constitution and Statutes Committee to address changes to the UNF Student Government Association Constitution, Statutes and Procedures, and:

WHEREAS:

Section 303.7 of Title III: <u>The Executive Cabinet</u> states: "All Executive Cabinet members are required to give an oral report at each Senate meeting. If a Cabinet member is unable to attend, than a written report shall be submitted instead," and;

WHEREAS:

Historically, Senate meetings have been rather lengthy. In the interests of time, the Constitution and Statutes Committee proposes to change the reporting procedure of Executive Cabinet members at Senate meetings, and;

THEREFORE:

LET IT BE ENACTED BY THE STUDENT SENATE THAT SECTION 303.7 OF TITLE III BE CHANGED TO READ: "ALL EXECUTIVE CABINET MEMBERS ARE REQUIRED TO GIVE A WRITTEN REPORT AT THE FIRST SENATE MEETING OF EACH TERM AND THEREAFTER ALTERNATING SENATE MEETINGS WITH AN ORAL REPORT TO BE GIVEN BY THE RESPECTIVE CABINET MEMBER. IF A CABINET MEMBER IS UNABLE TO ATTEND, THEN A WRITTEN REPORT SHALL BE SUBMITTED INSTEAD."
