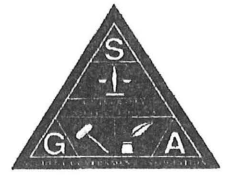

NUMBER SB-99S-1126

A request from the Society of Women's Engineers of \$766 to attend the Regional Society for Women's Engineers Conference in Tuscaloosa, Alabama.

- Whereas: The Student Government Association of the University of North Florida was established to represent student concerns in all University wide matters, and;
- Whereas: The Budget and Allocations Committee is one of four standing committees of the SGA Senate, which is responsible for the management of the A&S Budget, included in this the Student Conference Travel and Unallocated Reserve Accounts, and;
- Whereas: The Society for Women's Engineers is representative of the University of North Florida for the Electrical Engineering Program, and;
- Whereas: The Society of Women's Engineers is requesting monies to represent the University of North Florida at the Regional Society for Women's Engineers Conference in Tuscaloosa, Alabama, and;
- Whereas: The breakdown of monies is as follows:
