SENATE LEGISLATION

NUMBER SB-99S-1152A

A request from the UNF Jazz students of \$3905.50 from SGA Student Conference Travel to allow them to perform in the Notre Dame Collegiate Jazz Festival.

- Whereas: The Student Government Association of the University of North Florida was established to represent student concerns in all University wide matters, and;
- Whereas: The Budget and Allocations Committee is one of four standing committees of the SGA Senate, which is responsible for the management of the A&S Budget, included in this the Student Conference Travel and Unallocated Reserve Accounts, and;
- Whereas: The UNF Jazz studies program has gained notoriety and prestige throughout the years, and;
- Whereas: The UNF Jazz ensemble has been invited as a finalist in the Collegiate Jazz Competition and will perform at the Notre Dame Collegiate Jazz Festival, and;
- Whereas: The UNF Jazz ensemble is requesting monies to represent the University of North Florida as a finalist in the Collegiate Jazz Competition, and;

Whereas: The breakdown of monies is as follows:

Accommodations:	3 rooms x 3 nights @ \$109 a room/2	\$490.50
Transportation:	Van \$49 a day x 3 x 4 days	\$588
	Airline \$257 x 11	\$2827
Total		\$3905.50

Therefore: Let it be enacted that \$3905.50 be allocated from SGA Student Conference Travel Account (907027000) to allow the UNF Jazz Ensemble to compete as a finalist in the Collegiate Jazz Competition at the Notre Dame Collegiate Jazz Festival in South Bend, Indiana, on April 9 through April 12, 1999. With the understanding upon return from this trip the travelers have 30 days in which to report back to the Student Senate the benefits accomplished from this allocation.
