SENATE LEGISLATION

NUMBER SB-99S-1160

A Request from the Dottie Dorion Fitness Center from the SGA Unallocated Reserves Account (907098000) of \$22,337 to continue to run at full capacity until the next fiscal year.

Whereas:

The Student Government Association of the University of North Florida was established to

represent student concerns in all University wide matters, and;

Whereas:

The Budget and Allocations Committee is one of four standing committees of the SGA Senate, which is responsible for the management of the A&S Budget, included in this the Student

Conference Travel and Unallocated Reserve Accounts, and;

Whereas:

The Dottie Dorion Fitness Center on the University of North Florida campus is designed to

promote wellness and recreational activities for the students, and;

Whereas:

Due to the increase of demand and usage of the Dottie Dorion Fitness Center, the Dottie Dorion

Fitness Center is requesting monies to supplement the increased wages and maintenance due to

the increase in working hours per week, and;

Whereas:

This increase in the working hours per week was not authorized by the SGA Budget and

Allocations Committee, or the Student Senate, and;

Whereas:

Due to this negligence the Dottie Dorion Fitness Center is projected to have a negative balance in

its Salary Line of the Dottie Dorion Fitness Center Operating Budget for Fiscal Year 1998-1999,

and;

Whereas:

The Student Senate realizes the needs of the students and considered this Unallocated request

because it realizes that this increase in work hours per week was implemented by the voice of the

students, and;

Whereas:

The monies will be distributed with the acknowledgement that any A&S funded account

deviance that will project the account into a negative balance before the end of that fiscal year shall come before the Budget and Allocations Committee and the Student Senate for approval

prior to the change, and;

Whereas:

So that there will be no precedence set that A&S Funded Accounts may project to go into a

negative balance and be saved by requesting from the SGA Unallocated Account without first

prior approval from the Budget and Allocations Committee and the Student Senate, and;

Whereas:

The breakdown of the monies is as follows:

Wages for Fitness Trainers \$5.75 x 179hrs/week x 14 work weeks + FICA \$936.65=

\$15,347.00

Repairs and Maintenance for the equipment in the Fitness Center

\$6990.00

Total

\$22,337.00

Therefore:

Let it be enacted that a total of \$22,337.00 be allocated from the SGA Unallocated Reserves Account (907098000) to the Dottie Dorion Fitness Center Accounts: OPS Wages-\$15,347.00 and Operating Expense Detail Object Code/Category 240000 Repairs and Maintenance \$6,990.00 to continue to operate at full capacity for the students of the University of North Florida until the next fiscal year. This policy will be addressed in the fiscal year 1999-2000 A&S Budget Riders for all A&S funded accounts.
