Whereas:	Chapter 802.2 of the University of North Florida Student Government Association Constitution and Statutes states "the management of the A&S Budget is under direct control of the [B&A] Committee," and;	
Whereas:	The budget directors of the Activity and Service Fee Accounts of the University of North Florida have presented their proposals to the Student Government Association Budget and Allocations Committee throughout the Spring 1999 Semester, and;	
Whereas:	The Budget and Allocations Committee has used all resources at its disposal to best represent the entire student body at the University of North Florida in recommending this Activity and Service Fee budget allocation for the fiscal year 1999-2000, and;	
Whereas:	The committee has done an effective job of fulfilling its duty in this manner to the students of the University of North Florida, and;	
THEREFORE:	LET IT BE RESOLVED THAT THE ATTACHED ACTIVITY AND SERVICE FEE BUDGET ALLOCATING \$2,009,088.00 FOR THE 1999-2000 FISCAL YEAR, INCLUDING PROVISIONARY LANGUAGE, BE APPROVED BY THE STUDENT GOVERNMENT ASSOCIATION SENATE AT THE UNIVERSITY OF NORTH FLORIDA.
