## NUMBER SR-99SA-1197A

SR-99SA-1197 addresses the 1999 – 2000 discretionary tuition increase

- Whereas: The Student Government Association of the University of North Florida's purpose is to "represent students in all University-wide matters," as stated in chapter 400.1B, in the University of North Florida's Student Government Association Constitution and Statutes, and;
- Whereas: The students of the University of North Florida are aware of the rapid growth of the University and aware of the increasing costs of running an effective and efficient university, and;
- Whereas: The students of The University of North Florida have been exposed to a 23.4% increase in tuition over the last four years, and;
- Whereas: The students of The University of North Florida are greatly concerned with the possibility of another 5% discretionary increase in tuition, in addition to the 5% tuition increase imposed upon the Florida State University System by the Florida State Legislature this year, and;

**Therefore:**Let it be resolved that Dr. Anne H. Hopkins, President of the<br/>UNIVERSITY OF NORTH FLORIDA, BE AWARE OF THE STUDENTS' CONCERNS<br/>AND TAKE THEM INTO CONSIDERATION WHEN ESTABLISHING THE<br/>DISCRETIONARY TUITION INCREASE FOR THE 1999-2000 SCHOOL YEAR.

LET IT BE FURTHER RESOLVED THAT THE STUDENT GOVERNMENT ASSOCIATION OF THE UNIVERSITY OF NORTH FLORIDA DOES SUPPORT A MAXIMUM DISCRETIONARY TUITION INCREASE OF 2.5% FOR THE 1999-2000 ACADEMIC YEAR.
