WHEREAS: The Budget and Allocations Committee is standing committee of the Student Government Association Senate, which is responsible for "allocation of the Activity and Service Fees," and;

WHEREAS: The Mock Trial Club, a University Recognized organization requests monies for Regional and National trial competitions, and;

WHEREAS: The breakdown of monies is as follows:

Two Rental vans x 3 days	=	<b>\$216.66</b>
Accommodations: 2 rooms x 2 nights x 1/2	=	<b>\$250</b>
Subtotal of Regionals	=	<b>\$466.66</b>
<b>Nationals</b>		
Airfare \$466 x 8 persons	=	<b>\$3,928</b>
Accommodations: 2 rooms x 3 nights x 1/2	=	<b>\$360</b>
Subtotal:	=	<b>\$4,288</b>
<b>TOTAL:</b>	=	<b>\$5,354.66</b>
