SENATE LEGISLATION

NUMBER SB-99S-1292A

SB-99S-1292A changes Title VIII Chapter 809 on Transfers

WHEREAS: The Student Government Association of the University of North Florida was established to represent student concerns in all University wide matters, and;

WHEREAS: The Student Government Association Senate is responsible for "allocation of the Activity and Service Fees," and;

WHEREAS: The following lines in Chapter 809 <u>Transfers</u> of Title VIII are in conflict of each other:

- 809.1 Request for budget transfers must be submitted in writing to the B&A Committee, Senate, and SGA Senior Accountant. Upon approval by the SGA Senior Accountant, a budget amendment will be prepared and processed for authorized signatures.
- All transfers involving budget categories (Salary and Wages, OPS, OE, OCO) must have the signatures of the SGA Senior Accountant, Director of Student Development, and Vice President for Student Affairs.
- 809.3 All transfers between budget lines are subject to normal legislative procedures.
- 809.4 Any and all transfers between any line item or A&S Fee Account is subject to review by the B&A committee and forwarded to the Senate for final approval of transfer., and;
- WHEREAS: To alleviate the current problems that have been occurring with budget transfers, we propose that the following changes to this chapter be made:
 - 809.1Request for budget transfers must be submitted in writing to the B&A Committee, Senate, and SGA Senior Accountant.Upon approval by the SGA Senior Accountant, a budget amendment will be prepared and processed for authorized signatures.

809.2 Any and all transfers between any line item or A&S Fee Account is subject to review by the B&A committee and forwarded to the Senate for final approval of transfer.

809.3 All transfers between budget lines are subject to normal legislative procedures.

809.4 Any and all transfers between any line item or A&S Fee Account is subject to review by the B&A committee and forwarded to the Senate for final approval of transfer.

- 809.1 Request for budget transfers must be submitted in writing to the Budget and Allocations Chair.
- 809.2 Any and all transfers between any line item in A&S Fee Centralized Accounts must have the following signatures before being handed over to the Vice President of Student Affairs:
 - A) Budget and Allocations Chair
 - B) Senate President
 - C) SGA President
 - D) Senior Accountant
 - E) Comptroller

- 809.3 Upon approval of all the aforementioned signatures, a budget transfer will be prepared and processed.
- 809.4 If any signatures are not obtained, then the transfer goes before the Budget and Allocatiion Committee and forwarded on to the Student Senate for approval.
- 809.5 The Budget and Allocation Chair must inform the Student Senate of any and all transfers that go through the aforementioned process.
- 809.6 All Decentralized account transfers must come before the Budget and Allocations Committee and the Student Senate for approval.

THEREFORE: LET IT BE ENACTED THAT THE AFOREMENTIONED CHANGES TO TITLE VIII CHAPTER 809 BE MADE TO THE STATUTES OF THE UNIVERSITY OF NORTH FLORIDA'S STUDENT GOVERNMENT ASSOCIATION UPON APPROVAL OF JR-2000S-1302 AND THE APPROVED CHANGES TO THE 1999-2000 ACTIVITY AND SERVICE FEE BUDGET PROVISIONARY LANGUAGE.
