SENATE LEGISLATION

NUMBER SB-2000S-1296B

SB-2000S-1296B allocates travel funds for the Jax Christian Life

WHEREAS:

The Student Government Association of the University of North Florida was established

to represent student concerns in all University wide matters, and;

WHEREAS:

The Budget and Allocations Committee is standing committee of the Student

Government Association Senate, which is responsible for "allocation of the Activity and

Service Fees," and;

WHEREAS:

The Budget and Allocations Committee agreed upon the following request, and;

WHEREAS:

The Jax Christian Life requests funds from the Student Conference Travel Account

907027000 for travel to Orlando to attend the All Florida Winter Conference and;

WHEREAS:

The breakdown of monies is as follows:

Registration Fee

11 x \$65.00

= \$ 605.00

Transportation

2 minivans x 3 days

\$ 0.00

Total:

= \$605.00

THEREFORE:

Let it be enacted that \$605.00 be allocated from the Student Government Association's Student Conference and Travel Account for the Jax Christian Life to travel to Orlando to attend the All Florida Winter Conference on February 18th thru February 20th. HOWEVER, these funds shall not be disbursed until JCL becomes into compliance with Title VIII and provides sufficient evidence to the Student Senate that this has occurred. JCL shall have until the end of this semester to comply and receive these funds, otherwise, these funds shall be placed back into the Travel Account.
