NUMBER SB-00S-1338

SB-00S-1338 Changes Chapter 404.1 Regarding the Summation of Bills

- Whereas: The Student Government Association of the University of North Florida was established to represent student concerns in all University wide matters, and;
- Whereas: The Constitution and Statutes Committee is responsible for the review and revision of the SGA Constitution and Statutes when necessary, and;
- Whereas: The members of this committee, during deliberations on the Senate Policies and Procedures found some inconsistencies and felt that sections needed to be changed within Chapter 404.1 regarding the summation of bills passed by the Student Senate;
- Therefore: Let it be resolved that the following section be changed within Chapter 404.1 of the Student Government Association Statutes:

Chapter 404 Procedure for Approval of Bills

404.1 Summation of Bills

- A. ~~The Senate Secretary shall transmit any legislation passed by the Student Senate to the Senate President within two (2) school days after passage.~~
- A. The Senate President shall transmit any legislation passed by the Student Senate to the ~~Attorney General~~ SGA President within ~~two (2)~~ five (5) school academic days. ~~after receiving it from the Senate Secretary.~~
- B. Any legislation providing for a proposed constitutional amendment shall be submitted directly from the Senate Secretary President to the Attorney General Elections, Selections, and Appointments Chair for placement of the constitutional referendum on the next general election.
- C. All legislation that is not transmitted to the ~~Attorney General~~ SGA President within the allotted ~~four (4)~~ five (5) academic days will be referred back to the Student Senate.
