SENATE LEGISLATION

NUMBER SB-00SA-1345

SB-00SA-1345 makes changes to Title III of the Student Government Statutes.

- Whereas: The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
- Whereas: The Constitution and Statutes Committee is responsible for making revisions to the Student Government Constitution and Statutes as needed, and;
- Whereas: The Constitution and Statutes Committee is conducting a full statutory review of all thirteen (13) statutes, and;
- Whereas: The Constitution and Statutes Committee determined during its review of Title III that the following changes are necessary, and;

Therefore: Let it be enacted that the following changes be made to Title III: The Executive Branch:

- 303.3 **The Executive Cabinet shall meet on a regular basis no less than once every ~~two-weeks~~ 31 days during the fall and spring semesters.**
- 305.2B **Development of policy on the operation of the Student Government Executive Cabinet.**
- 307.1 **The Office of Graduate and Non-Traditional Student Affairs (O.G.A.) is an administrative support office responsible for providing information and program options to the Executive Office on all matters concerning graduate, professional, ~~mature~~, non-traditional, and returning student needs, issues, or concerns.**
- 314.2D **~~Shall serve on the Board of Directors of the Women's Center.~~**
- 315.1B **Advertisements must run, in a widely distributed print media forum at least ~~three days~~ once during the candidate search time period.**
- 316.1A **~~The Office of Public Relations shall conduct a candidate search.~~**
- 316.1B **~~The Office of Administration shall screen the applicants in a manner designated by the Student Government President.~~**
