# SENATE LEGISLATION

## NUMBER SB-00F-1361

*SB-00F-1361 makes changes to Title VII of the Student Government Statutes.*

- Whereas: The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and;
- Whereas: The Constitution and Statutes Committee is responsible for making revisions to the Student Government Constitution and Statutes as needed, and;
- Whereas: The Constitution and Statutes Committee is concluding a full statutory review of all thirteen (13) statutes, and;
- Whereas: The Constitution and Statutes Committee determined during its review of Title VII that the following changes are necessary, and;
- Therefore: Let it be enacted that the following changes be made to Title VII: The Impeachment Statutes:

- 704.1 Once a Senator obtains more absences than allowed per the Senate Policies and Procedures, it will be the responsibility of the Senate President Pro-Tempore to notify the Senator in question via telephone, electronic mail, or U.S. mail that they have violated the limit. If the Senator in question is the Senate President Pro-Tempore, then it will be the responsibility of the Senate President to carry out this duty.
- 704.2 Within two weeks of notification of the Senator, the Constitution and Statutes Committee will meet to answer any appeal to that Senator's removal from the Student Senate. If the Senator does not appear at the meeting or does not file an appeal, then he/she is automatically removed from his/her Senate seat. Any appeals to the decision of the Constitution and Statutes Committee may be made to the Office of the Judiciary.
