| 1 | | SB-01S-1400 makes changes to the policy for Senate and Judicial Scholarships. |

| 2 3 | Whereas: | The Student Government of the University of North Florida was established to represent student concerns in all University wide matters, and; |
| 4 5 6 | Whereas: | The Constitution and Statutes Committee is responsible for "reviewing the SG Constitution and Statutes and recommend any change to the SG Senate when necessary," and; |
| 7 8 9 | Whereas: | During the Summer of 1999, the Student Senate passed SB-99SB-1229, which revised the \$200 scholarship program for members of the Senate and Judiciary, by a vote of 13-2-0, and; |
| 10 11 | Whereas: | Since that time, several changes have occurred throughout Student Government requiring the updating of this bill, and; |
| 12 | Whereas: | The Student Senate now has forty-six members, not forty, and; |
| 13 14 15 16 17 18 | Therefore: | Let it be enacted that the members of the Student Senate who serve one uninterrupted calendar year within the Senate without violating Chapter 401.1 and members of the Office of the Judiciary who serve one uninterrupted calendar year be eligible for a \$200 scholarship as an endeavor to compensate the Student Senate and the Office of the Judiciary for their time, effort, and dedication to the students of the University of North Florida. |
| 19 | Further: | Let it be further enacted that this scholarship be paid out of the scholarship account. |
| 20 21 | Further: | Let it be further enacted that this scholarship be retroactive to one year from the date of passage by the Student Body President. |
