# SENATE LEGISLATION

## SB-02SA-1560

6 *SB-02SA-1560: Adds onto Title X Chapter 1003, which will set a time limit to be sworn into office.*

7 Whereas: The Student Government of the University of North Florida was established to represent  
8 student concerns in all University wide matters, and;

9 Whereas: Senators are elected officers that may only exercise said powers upon taking the oath of  
10 office, and;

11 Whereas: The student body of the University of North Florida elect students to be senators, and;

12 Whereas: Some students were elected to office and have not been sworn in and thus they cannot  
13 carry out the duties that they have been elected to do by the student body, and;

14 Therefore: Let it be enacted that the following clause be added to Title X Chapter 1003 regarding  
15 the Installation of Student Government Officials

16 1003.6

17 Student Government Senators are sworn in at the next Senate Meeting following the  
18 confirmation of elections. Any Senator that has not taken the oath of office by the next  
19 regularly scheduled Senate Meeting following the swearing-in ceremony; the senator-  
20 elect will automatically forfeit any rights, privileges, and duties that accompany the  
21 office of Senator.
