6 *SB-02F-1590: Validates the Fall 2002 General Election and Inter-Collegiate Election*

7 Whereas: The Student Government of the University of North Florida was established to represent
8 student concerns in all University wide matters, and;

9 Whereas: The Fall 2002 General Election and Inter-Collegiate Election, as provided for by the
10 Constitution were properly conducted, and;

12 the elections, and;
