# SENATE LEGISLATION

## NUMBER SB-02F-1595

### SB-02F-1595: Omnibus June 30<sup>th</sup> Encumbrances Request

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student  
5 Government Senate, responsible for funding only those entities that comply with  
6 the Student Government mission which is to represent student concerns in all  
7 university wide matters while developing and promoting programs and activities  
8 of practical value and interest to students, and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the  
10 educational, social, cultural, and recreational interests of the University of North  
11 Florida students, and;

12 Whereas: Per provisional language, encumbrances that cannot be paid from last years  
13 budget can be requested through unallocated in the next years budget, and;

14 Whereas: These were the requests turned in to the SG Comptroller:
