# SENATE LEGISLATION

## NUMBER SB-03S-1645

### SB-03S-1645: Student Council for Exceptional Children Travel Request

1

2 Whereas: The Student Government of the University of North Florida was established to represent  
 3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
 5 Senate, responsible for funding only those entities that comply with the Student Government  
 6 mission which is to represent student concerns in all university wide matters while  
 7 developing and promoting programs and activities of practical value and interest to students,  
 8 and;

9 Whereas: The Student Council for Exceptional Children is a club on campus that supports the  
 10 education of students with learning disorders, and;

11 Whereas: They wish to attend the CEC Annual National Conference and Expo to learn and then  
 12 reeducate these skills, and;

13 Whereas: The cost of the trip would be:

14 Registration:  $900.00 = \$100 * 9 \text{ Students} = 0$  (College of Education \$900)  
 15 Lodging:  $300.00 \text{ or } 400.00 = 2 \text{ Rooms} \times 5 \text{ Nights} \times \$80.00 \times 0.5$  (College of Education \$100)  
 16 Transportation:  $1800.00 = 9 \text{ Plane Tickets} \times \$200.00$   
 17 Total:  $3100.00$ , and; \$2100.00

18 Therefore: Let it be enacted, by the University of North Florida Student Government,  
 19 that \$2,100.00 from the travel account 907027000 fund the SCEC conference  
 20 trip to the CEC Annual National Conference and Expo in Seattle,  
 21 Washington.
