SB-03S-1649: Women's Center Transfer

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student
5 Government Senate, responsible for funding only those entities that comply with
6 the Student Government mission which is to represent student concerns in all
7 university wide matters while developing and promoting programs and activities
8 of practical value and interest to students, and;

9 Whereas: The Women's Center is a Student Government funded center, and;

→10 Whereas: The Women's Center needs some extra funds for emergency use, and;

11 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
12 **that \$500.00 be transferred from OPS to OE in the Women's Center Account**
