NUMBER SB-03S-1670

1 ***SB-03S-1670 Validates the Spring 2003 General Election and Inter-Collegiate Election.***

2 Whereas: The Student Government of the University of North Florida was established to represent student
3 concerns in all University-wide matters, and;

4 Whereas: The Spring 2003 General Election and Inter-Collegiate Election, as provided for by the Constitution
5 were properly conducted, and;

6 Whereas: Title VI requires the results of each election be validated at the Senate meeting following the
7 elections, and;

8 Therefore: Let it be enacted that the Spring 2003 General Election and the Inter-Collegiate Election results be
9 validated as shown below.
