**BLUE CROSS AND BLUE SHIELD OF FLORIDA INTRODUCES  
LOW-COST MEDICARE SUPPLEMENT INSURANCE PLAN  
FOR MEDICARE BENEFICIARIES IN SOUTHWEST FLORIDA**

FORT MYERS -- Blue Cross and Blue Shield of Florida (BCBSF) today introduced **Advantage65 Select**, a low-cost Medicare supplement insurance (Medigap) plan for Medicare beneficiaries in Lee and Charlotte Counties. **Advantage65 Select** is the result of a unique agreement between BCBSF and area health care providers.

In addition to premiums which are approximately 20-percent lower, another **Advantage65 Select** feature which makes it an attractive alternative is low-cost access to quality health care from both physicians and hospitals.
