# SENATE LEGISLATION

## SB-03SB-1698

6 **SB-03SB-1698: Adds the requirement of an Effective date to statutory Bills in Title IV**

7 Whereas: The Student Government of the University of North Florida was established to represent  
8 student concerns in all University wide matters, and;

9 Whereas: The Statutes are the governing documents of the University of North Florida Student  
10 Government, its officers and all students serving in any capacity whatsoever within  
11 Student Government, and;

12 Whereas: The Senators are elected officials with the authority to review and make changes to the  
13 Statutes, and propose Statutory Bills, and;

14 Whereas: The Statutes should be officially altered only once annually at the beginning of the fiscal  
15 year to maintain consistency in Student Government and the integrity of the Statutes,  
16 and;

17 Whereas: Statutory changes approved by Senate may only become effective on July 1 of the coming  
year, and all Statutory Bills must include in writing the July 1 effective date, and;

19 Whereas: Exceptions to the effective date requirement exist and are defined in Title IV of Statutes,  
20 and;

21 Therefore: Let it be enacted that the following changes be made to Title IV Chapter 403 regarding  
22 the Effective Date requirement:

23 403.7 will become 403.8, and the new 403.7 will read as

24 403.7 Effective Date

25 **A. All statutory Bills must include an effective date of July 1 of the coming year.**

26 **B. The only exception to the effective date for statutory Bills is if three-fourths of Senate**  
27 **approves the Bill for Emergency passage.**
