SB-03F-1711A: Recreation Field Lighting Request

- 2 Whereas: The Student Government of the University of North Florida was established to represent
- 3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
- 5 Senate, responsible for funding only those entities that comply with the Student Government
- 6 mission which is to represent student concerns in all university wide matters while
- 7 developing and promoting programs and activities of practical value and interest to students,
- 8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
- 10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: The Recreation Field Lighting would provide areas for recreation for students on
- 12 campus, thereby allowing students to become more physically active on campus;
- 13 Whereas: The following expenditures would allow the Recreation Field Lighting to serve
- 14 the students of the University of North Florida:
- 15 Installation of Poles and Electrical: \$62,700.00
- 16 Musco Lighting System with 30 ft. Candle Guarantee, 10-year maintenance
- 17 warranty, and Control Link System: \$96,780.00
- 18 **Total: \$159,480.00**
- 19
- 20 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
- 21 **that \$159,480.00 from the Fund Balance be used to pay for the Recreation**
- 22 **Field Lighting.**
