SB-03F-1712: ADA Food and Nutrition Conference Travel

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Nutrition Club is a student organization of the University of North
12 Florida;

13 Whereas: The total amount of money requested is broken down into:

14	Registration Fees:	4 * \$140.00 * ½	\$760.00
15	Accommodations:	2 Rooms * (\$115 and \$159)/night * 4 * ½	\$320.00
16	Transportation:	4 tickets * \$315.50 * ½	<u>\$1,262.00</u>
17	Total Amount Requested:		<u>\$2,342.00;</u>

19 Therefore: Let it be enacted, by the University of North Florida Student Government, that
20 \$2,342.00 from the travel account 907027000 be used to pay for conference travel
21 for the Student Nutrition Club.
