**SB-03F-1714: Changes to Title III - The Executive Branch**

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be  
9 considered by the Student Senate;

10 Whereas: The Executive Branch Statute is in need of revision and simplification;

11 Whereas: The Student Senate's responsibility is to make our statutes proper for the needs of  
12 our students;

13 Whereas: Within this statute is listed Administrative Offices that are not necessary according  
14 to Title III for use, yet are codified;

15 Whereas: The Student Body President has the ability to create administrative offices with  
16 written notification given to the Senate President, requiring no codified office  
17 responsibilities;

18 Whereas: The Student Government Treasurer is an Executive Officer not belonging to the  
19 Executive Cabinet;

20 Whereas: Attached to this legislation is the proposed amended and updated copy;

21 **Therefore: Let it be enacted, by the University of North Florida Student**  
22 **Government that the proposed revisions are made into Title III of the**  
23 **SG Statutes.**
