# SENATE LEGISLATION

## NUMBER SB-03S-1728

### SB-03S-1728: Chi Alpha Southeast SALT Conference Travel Request

1

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: Chi Alpha will be representing our university and its student body in Atlanta, GA at the  
10 Southeast SALT Conference, from 9 AM December 28, 2003 through 8 PM January 1, 2004.  
11 This conference would provide leadership training and promote diverse leadership on the  
12 UNF campus;

13 Whereas: SG would pay for:

14 Registration: \$60 \* 14 students = \$840;

15 Lodging: 1/2 \* 4 nights \* 4 rooms \* \$60 / night = \$480;

16 Total: \$1,320

17 Therefore: Let it be enacted, by the University of North Florida Student Government,  
18 that \$1,320.00 from the Travel Account 907027000 be used to pay for 14  
19 members of Chi Alpha to travel to Atlanta, GA from December 28, 2003 to  
20 January 1, 2004.
