## NUMBER SB-04S-1759

### *SB-04S-1759: Council for Exceptional Children Travel Request*

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
social, cultural, and recreational interests of the University of North Florida students and;

10 Whereas: The Student Council for Exceptional Children travel request will allow the  
11 students of the University of North Florida to attend a national conference of the  
12 Council for Exceptional Children from April 15, 2004 to April 17, 2004 in New  
13 Orleans, LA. The following expenditures will allow this to occur:

15 Registration: \$919

16 Transportation: \$1,204

17 **Total: \$2123**

18 **Therefore: Let it be enacted, by the University of North Florida Student Government,**  
19 **that \$2123 be used from the Travel Account 907027000 to fund the Council**  
20 **for Exceptional Children Travel Request to attend the Council for**  
21 **Exceptional Children 2004 Convention and Expo from April 15, 2004 to**  
22 **April 17, 2004 in New Orleans, LA.**
