# SENATE LEGISLATION

## SB-04SA-1774

### *SB-04SA-1774 : Title VI - General Revisions*

2 Whereas: The Student Government of the University of North Florida was established to  
3 represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's  
5 Student Government given the responsibility of carrying out such legislative acts  
6 that are necessary and proper for the Student Body of the University of North  
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be  
9 considered by Student Senate;

10 Whereas: The Elections Statutes is in need of revision;

11 Whereas: The Student Senate's responsibility is to make our statutes proper for the needs  
of our students;

13 Whereas: The following changes will amend Title VI allowing for better organization and  
14 easier reading;

15 Whereas: The following changes will be made to Title VI:

16 *Presidential/Vice- Presidential Election*

17 600.1 U. Ticket- Two (2) candidates cooperatively engaged in a campaign for  
18 president and vice-president of SG. ~~A vote for that ticket will count~~  
19 ~~equally for each candidate on the ticket. All Presidential/Vice-~~  
20 ~~Presidential candidates must run as a ticket.~~

21 602.2 B. All Presidential/Vice-Presidential candidates must run as a ticket.

22 602.2 C. A vote for a Presidential/Vice-Presidential ticket will count equally for  
23 each candidate on that ticket.

24 *Certificate of Election*

25 600.1 E. Certificate of Election- A document certifying a candidate's  
26 proper election. ~~The SG President and the Elections Supervisor~~  
27 ~~must sign this document.~~

607.3 C. The SG President and the Elections Supervisor must sign the Certificate of Election to certify the candidate's proper election.

602.1 D. Seat forty-one (41) shall be occupied by the candidate receiving the most votes who also fulfills the requirements outlined in Section 3B of Article II. This seat shall take priority over the remaining at-large seats in that it, if possible, shall be allotted to the qualified candidate with the most votes prior to the allotment of at-large seats.
