SENATE LEGISLATION

SB-04SA-1776

SB-04SA-1776 : Title VI -The Poll

2 Whereas: The Student Government of the University of North Florida was
3 established to represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North
5 Florida's Student Government given the responsibility of carrying out
6 such legislative acts that are necessary and proper for the Student Body of
7 the University of North Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by Student Senate;

10 Whereas: The Elections Statutes is in need of revision;

11 Whereas: The Student Senate's responsibility is to make our statutes proper for the
12 needs of our students;

13 Whereas: Currently, only candidates are restricted from standing over voters while
14 they complete their ballot, thus anyone involved in campaigning that is
15 not a candidate is permitted to standing over voters;

16 Whereas; This Amendment shall allow no individual the right to stand over any
17 voter(s) while they complete their ballot, except in the case which a poll
18 worker or representative of the disability resource center assists an
19 individual with a disability;

20 Whereas; The current means for identification at the polls is vague and leaves it
21 open for extreme interpretation;

22 Whereas; Proper identification shall be restricted to such documents that are
23 provably accurate;

24 Whereas: The following changes will be made to Title VI:

1 **SB-04SA-1776 : Title VI -The Poll (Continued)**

2 *Assistance at the Polls*

3 605.2 A. Candidates ~~No individual~~ may ~~not~~ stand over voters while they
4 complete their ballot, except in the case of a disability; an individual with
5 a disability is permitted to request a poll worker or a representative from
6 the Disability Resource Center to assist the voter.

7 *Identification at the Polls*

8 606.2 C. 7. The University of North Florida Student Identification card shall serve as
9 a student voter registration card for campus elections. If necessary, a
10 valid Drivers License, Military Identification card, Passport, or State
11 issued Identification card ~~or other valid identification card~~ may be
12 accepted, but must be cross-referenced immediately with a student
13 registrar list.

14 **Therefore: Let it be enacted, by the University of North Florida Student**
15 **Government, that the proposed revisions are made into Title VI of the**
16 **Student Government Statutes.**
