SENATE LEGISLATION

SB-04SA-1780

SB-04SA-1780 : Title VI - Incumbents

2 Whereas: The Student Government of the University of North Florida was
3 established to represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North
5 Florida's Student Government given the responsibility of carrying out
6 such legislative acts that are necessary and proper for the Student Body of
7 the University of North Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by Student Senate;

10 Whereas: The Elections Statutes is in need of revision;

11 Whereas: The Student Senate's responsibility is to make our statutes proper for the
12 needs of our students;

13 Whereas: Incumbents should not be required to acquire student endorsement due to
14 the fact that the students voted these individuals into office;

15 Whereas; Incumbents should be notated on the official ballot to remind the
16 constituency of their current office;

17 Whereas: The following changes will be made to Title VI:

18 604.2 B. 3. c. Presidential/Vice-Presidential incumbents, in which both
19 individuals are the same and running for the same office, are not
20 required to receive student endorsement.

21 604.2 B. 3. e. Elected Senatorial candidates, whom are running in the same
22 general election or for the same college seat, are not required to
23 receive student endorsement.

24 606.3 A. 7. Presidential/Vice-Presidential incumbents, in which both
25 individuals are the same and running for the same office, shall
26 be denoted on the official ballot.

1 **SB-04SA-1780: Title VI -Incumbents (Continued)**

2 **606.3 A. 7.** Elected Senatorial incumbents, whom are running in the same
3 general election or for the same college seat, shall be denoted on
4 the official ballot.

5 **Therefore:** Let it be enacted, by the University of North Florida Student Government, that the
6 proposed revisions are made into Title VI of the Student Government Statutes.
