# SENATE LEGISLATION

## SB-04SA-1781

### SB-04SA-1781: Campaign Expenses

6

7 Whereas: The Student Government of the University of North Florida was established to represent  
8 student concerns in all University wide matters, and;

9 Whereas: The Student Senate is the legislative body given the responsibility of considering all  
10 legislation necessary and proper to the Student Body;

11 Whereas: The campaign expense limits do not allow for the growth of the University of North  
12 Florida Student Body;

13 Whereas: Candidates for President and Vice-President are limited to spending \$1500.00. Instead,  
14 the candidates for President and Vice-President should be allowed to spend 15 cents  
15 (\$0.15) per the number of students enrolled in the University of North Florida. This  
16 guideline will serve as a replacement for the existing inflexible amount that does not  
17 allow for an escalation in the size of this Student Body.

18 605.3 B.1.: President and Vice-President - The amount a ticket for president and vice-president may  
19 spend is 15 cents (\$0.15) per student enrolled after the first fourteen (14) business days of the Spring  
20 semester. The amount of money that a ticket may spend will be posted five (5) business days before  
21 the beginning of the campaigning period.

22 Therefore: Let it be enacted, by the University of North Florida Student Government that the  
23 proper revisions are made into Title IV, 605.3 B.1.
