SB-04SB-1791

SB-04SB-1791 : Effective Date Override

- 2 Whereas: The Student Government of the University of North Florida was
3 established to represent student concerns in all University wide matters;
- 4 Whereas: The Student Senate is the legislative body of the University of North
5 Florida's Student Government given the responsibility of carrying out
6 such legislative acts that are necessary and proper for the Student Body of
7 the University of North Florida;
- 8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by Student Senate;
- 10 Whereas: Several bills were passed at the previous Senate meeting and signed off by
11 the Student Body President with the intent of falling within the July 1,
12 2004 effective date;
- 13 Whereas: It has been questioned to the Judiciary whether those bills were eligible to
14 fall within the July 1, 2004 effective date;
- 15 Whereas: This bill shall be to override the effective date according to Title IV of the
16 University of North Florida Student Government Statutes allowing those
17 bills to follow the intent of the Legislative and Executive Branches when
18 they were passed;
- 19 **Therefore: Let it be enacted, by the University of North Florida Student**
20 **Government, that the following bills shall take effect immediately:**
- 21 SB-04S-1767 SB-04SA-1772 SB-04SA-1778 SB-04SA-1779 SB-04SA-1780
