## SB-04SB-1797

### SB-04SB-1797: Osprey Productions NACA Conference Travel Request

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;
- 4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;
- 9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;
- 11 Whereas: Osprey Productions requests money for eight committee chairmen to travel to the  
12 Regional NACA programming conference in Winston-Salem, NC from Thursday,  
13 October 7<sup>th</sup> at 9 am to Sunday, October 10<sup>th</sup> at 9am to enhance their ability to  
14 provide more quality and cost effective programming to UNF students, as well as  
15 to network with individuals in the local entertainment industry.
- 16 Whereas: The total amount of money requested is broken down into:
