SB-04F-1800: Library Extra Hours

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: Due to recent monetary issues the library has cut operation hours to the pre-2001
12 hours. In 2001 Student Government decided to fund extra hours of operation for
13 the library to assist students with a place to study and research after normal hour
14 of operation;

15 Whereas: The students of the University of North Florida have spoken out at the cut in
16 operation hours of the library. It is in the best interests of the students to reinstate
17 the previous hours and extend weekend library hours;

18 Whereas: The following expenses shall be paid to fund extra hours at the library:

19 15 hours/wk * \$10/hr * 2 persons * 2 wk (pay period) * 2 pay periods = \$12,000.00

20 **Total: \$12,000**

21 **Therefore: Let it be enacted, by the University of North Florida Student Government,**
22 **that \$12,000.00 from the Special Request account 907098000 to the Special**
23 **Projects account 907041000 be used to pay for the extra hours of operation**
24 **for the University of North Florida Library.**
