SENATE LEGISLATION

SB-04F-1801

SB-04F-1801: Title VI - Election Dates

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts
6 that are necessary and proper for the Student Body of the University of North
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be considered
9 by Student Senate;

10 Whereas: The Election Statutes are in need of revision and it is the Student Senate's
11 responsibility is to make our statutes proper for the needs of our students;

12 Whereas: The current window for election dates allow only a two week deviation in the
13 election dates and do not take into consideration conflicts with University
scheduling such as holidays and Spring Break;

15 Whereas: The following changes would allow a window to plan the Fall and Spring Elections,
16 but would not allow the elections to cut or add a significant amount of time from an
17 elected official's term in office;

18 Whereas: The following changes will be made to Title VI:

19 603.1 A. Fall Elections shall take place no less than five weeks and no more than
20 ~~seven~~ eight weeks from the beginning of the Fall Semester

21 603.1 B. Spring Elections shall take place no less than ~~four~~ three weeks and no
22 more than ~~six~~ seven weeks prior to the end of the Spring Semester.
23 Spring Elections shall take place no less than fifty (50) weeks and no
24 more than fifty-four (54) weeks from the previous Spring Election.

25 Therefore: Let it be enacted, by the University of North Florida Student Government that the
26 proposed revisions are made into Title VI of the Student Government Statutes.
