## SB-04F-1803

### SB-04F-1803: ADA Food and Nutrition Conference Travel

2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government  
5 Senate, responsible for funding only those entities that comply with the Student Government  
6 mission which is to represent student concerns in all university wide matters while  
7 developing and promoting programs and activities of practical value and interest to students,  
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,  
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: The Student Nutrition Club is a student organization of the University of North  
12 Florida, seeking to attend ADA food and Nutrition Conference in Anaheim  
13 California from October 1<sup>st</sup> 2004 to October 6<sup>th</sup> 2004;

14 Whereas: The total amount of money requested is broken down into:

15	Registration Fees:	10 * \$214.00	\$2,140.00
16	Transportation:	10* \$276.00	\$2,760.00
17		- \$1000.00 College of Health Contribution	
18	<b>Total Cost of Event:</b>		<b>\$3,900.00</b>
