SB-04F-1804: WOSP Osprey Radio Conference Travel

2 Whereas: The Student Government of the University of North Florida was established to represent
3 student concerns in all University wide matters, and;

4 Whereas: The Budget and Allocations Committee is a standing committee of the Student Government
5 Senate, responsible for funding only those entities that comply with the Student Government
6 mission which is to represent student concerns in all university wide matters while
7 developing and promoting programs and activities of practical value and interest to students,
8 and;

9 Whereas: This purchase or activity reflects the genuine student interest and enhances the educational,
10 social, cultural, and recreational interests of the University of North Florida students and;

11 Whereas: WOSP Osprey Radio is a student organization of the University of North Florida
12 seeking to travel to New York, New York from October 12, 2004 to October 17,
13 2004, in order to gain insight and information on enhancing its broadcasting
14 potential, through attending the CMJ Music Marathon Conference.

15 Whereas: The total amount of money requested is broken down into:

16	Registration Fees:	\$245*3 students	\$735.00
17	Transportation	3 tickets*\$239	\$717.00
18	Lodging	3 students*1 rm*5 ngt*\$153	\$383.00
19	Shuttle	Flat fee	\$60
20	Total Amount Requested:		\$1,895.00
