### *SB-04F-1814: Fall 2004 Elections Validation*

- 2 Whereas: The Student Government of the University of North Florida was established to represent  
3 student concerns in all University wide matters;
- 4 Whereas: The Student Senate is the legislative body of the University of North Florida's Student  
5 Government given the responsibility of carrying out such legislative acts that are  
6 necessary and proper for the Student Body of the University of North Florida;
- 7 Whereas: The Fall 2004 General Election and Inter-Collegiate Elections, as provided for by the  
8 Constitution were properly conducted;
- 9 Whereas: Title VI requires the results of each election be validated at the Senate meeting following  
10 the elections;
- 11 Therefore: Let it be enacted that the Fall 2004 General Election and the Inter-Collegiate Elections  
12 results be validated as written below:
