8 9	Whereas:	Legislation dealing with necessary and proper statutory revisions shall be considered by Student Senate;
10	Whereas:	The Elections Statutes is in need of revision;
11	Whereas:	The Student Senate's responsibility is to make our statutes proper for the needs of our students;
13 14	Whereas;	The following addition would require the ESAC Chairman to maintain an accurate contact list of current senators;
15	Whereas:	The following changes will be made to Title VI:
16 17 18 19 20		601.1 O. To maintain an accurate list of active senators' contact information. Upon making revisions to the contact list, it is the Chairman's responsibility to forward copies to the Senate President, Senate President Pro-Tempore, Committee Chairmen, and Senate Secretary.
21 22 23	Therefore:	Let it be enacted, by the University of North Florida Student Government that the proposed revisions are made into Title VI of the Student Government Statutes.
